From the Desk of Ms. Peterson, Superintendent

Iowa Department of Education Site Visit Report:

The Department of Education conducted their Site Visit of our school this past February 9th-11th. Their written report is complete and has been sent to us. This report is based upon interviews conducted with district administrators, teachers, support staff, parents, students, community partners, advisory committee members and board members, as well as a review of district documents.

The DE Site Visit was designed to assess progress with the Comprehensive School Improvement Plan, provide a general assessment of educational practices within the district, make recommendations for improvement, and determine compliance with accreditation standards and federal program requirements.

Based on their findings from this comprehensive site visit, the Martensdale-St. Marys Community School does maintain State of Iowa Accreditation upon resolution of any non-compliance issues. The district must complete corrective actions in regard to non-compliance issues and turn those into the Department of Education according to the timeline listed.

Overall, we were very pleased with the findings in this Site Visit Report. There were many strengths for our school district listed. There were also some recommendations for improvement indicated as well. We will be working with our teachers to come up with an action plan to address all of these recommendations.

State of the MStM School Budget:

As I have written in the past, the Governor's Across the Board Cut this year amounted to \$248,479 for our school. Last year, we were also cut 1.5% which totaled \$33,590 (that was not funded this year as well) and the Phase I dollars (this is the money that was to bring all teachers up to the state minimum salary) were cut too which totaled \$71,000. The total cuts for

our school district amounts to \$353,069. That total, as you can imagine, is a lot of money for our small school district.

As you are aware, we did make some cuts to support staff this past December. Bob Sondag, our Industrial Technology teacher, also decided to take early retirement at the end of first semester. Bob's early retirement and the cuts to the support staff amounted to \$75,372. This will be a savings of approximately \$150,744 for a full year.

At this time, we do not intend to fill Bob's position for next year. We have enough vocational courses to fulfill the state accreditation standards. As money becomes available, we do plan to replace this position at some point in the future. We will also look to share this industrial technology program with other area schools for next year.

Depending on what the legislature decides this spring and how teacher negotiations go, we will probably have to make some more cuts to staff – approximately one to two teaching positions and some cuts to Schedule B positions (extra-curricular contracts) too. The Governor has issued a press release calling for 2% allowable growth, including his budget plan to use \$100 million out of the state's cash reserves, and \$40 million in remaining federal stimulus money (as of right now, this stimulus money will not be there after next year) to pay for it. Although this sounds promising, please be aware that this still short funds our allowable growth by approximately \$300 per enrolled student.

We will not know what the legislature is going to do until their session is over which is scheduled for March 31st. We will also have to see how our teacher negotiations go. I will be working with our Board of Education to make sure we are ready for any scenario so that we can keep being a fiscally sound school district.

From the Desk of Mr. Crozier

Spring has sprung and it is time to get out and enjoy it. We have been very busy at Martensdale-St. Marys over the past snowy winter months.

I would like to tell you about the Healthy Kids Act that the Iowa legislature passed last year. This legislation has had and will continue to have an effect on schools. The act consists of three concepts of health: physical activity, diet, and CPR.

Healthy Kids Act Impacts Iowa Schools

In May of 2008, the Iowa Healthy Kids Act was signed into law by Governor Culver. This law will affect Iowa's K-12 schools in the following ways:

- Established nutritional content standards for food and beverages sold or provided on school grounds during the school day. *Effective July 1, 2010.*
- Requires school districts and accredited non-public schools to ensure every student in grades K-5 has 30 minutes per day of physical activity and every student in grades 6-12 has 120 minutes per week of physical activity. *Effective July 1, 2009.*
- Requires every student to complete a course that leads to certification in cardiopulmonary resuscitation (CPR) by the end of grade 12. *Effective for the class of 2011-2012.*
- Requires Iowa's Area Education Agencies (AEAs), or a consortium of two or more AEAs, to contract with a licensed dietitian. *Effective July 1, 2009.*

The Healthy Kids Act was designed to help children develop healthy eating habits, to promote active lifestyles, and to provide students with a solid foundation for a better future. Healthy Kids Act Nutritional Content Standards Take Effect

You and your students may notice changes in the foods being sold during the school day this year. As of July 1, 2010, the Healthy Kids Act Nutritional Content Standards will become effective in Iowa Schools. The standards will apply to vending, a la carte, and regulated fundraising (any foods/beverages sold to students between the first and last bell) items sold to students during the school day.

Regulated food categories include:

- Calories
- Sodium
- Total Fat
- Saturated Fat
- Trans Fat
- Sugar
- Dietary Fiber/Whole Grain

Regulated beverage categories include:

- Milk
- 100% Juice
- Water
- Sports Drinks/Flavored Water
- Caffeinated Beverages
- Sodas/Carbonated Beverages

The school district has a standing wellness committee that will monitor our compliance with the Healthy Kids Act. This committee is made up of K-12 teachers, board members, administrators, parents and students.

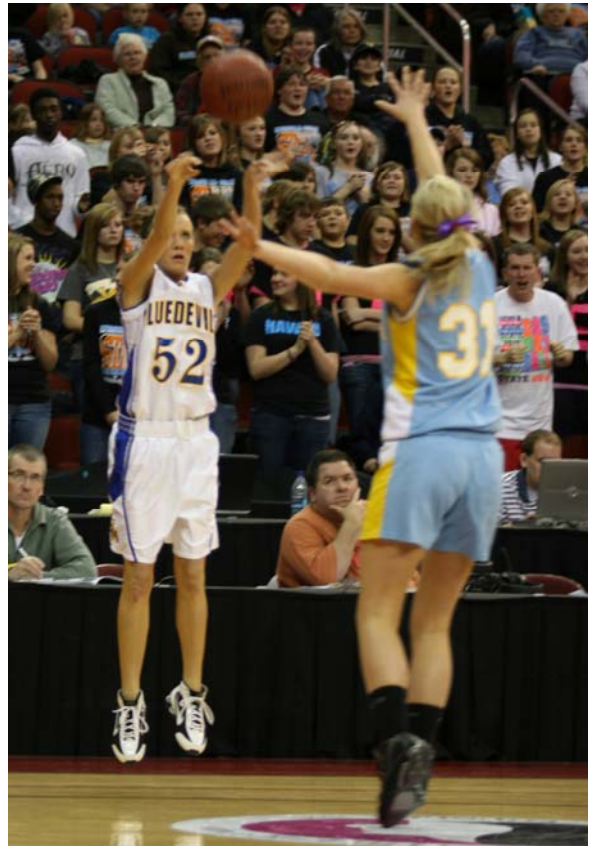

Cheating

Studies have found that most children have cheated, or thought about cheating, on schoolwork. While schools battle this issue, there are two important things parents can do to help. First, from the time children are very young, parents must emphasize and reward honest behavior. Second, parents must make sure that their children know that cheating will not be tolerated at home or at school. Here are some more ways parents can stop children from cheating.

Stop schoolwork-related cheating by: Monitoring writing projects.

Plagiarism—passing off others’ words or ideas as your own—used to mean copying a few lines or paragraphs from an encyclopedia. Today, with the help of the Internet, children can steal entire essays and research papers. Read your children’s assignments before they turn them in. If the writing doesn’t “sound” like theirs, talk with them about how they came up with the ideas. If necessary, explain that plagiarism is a serious form of stealing that can result in failing grades or even expulsion.

Believing the teacher.

Teachers don’t make accusations of cheating lightly. If the teacher says that your child was cheating, avoid getting defensive. First, get the facts. Then, if necessary, set up a meeting with everyone involved. Finally, establish consequences both for the specific incident and for any “repeat performances.”

Fighting peer pressure.

Peer pressure can be difficult to handle. Children may have a hard time rebuking a friend who asks to copy homework or peek at test answers. Remind your children that it’s OK to say “no” to their friends. Let them use you as an excuse: “Sorry. My parents would be furious if I let you see my homework.”

Allowing your children to do their own work.

Giving your child a little guidance about a school project is fine. Doing even a small bit of the work for them is cheating. You know it. Your child knows it. And so does the teacher.

Battle other kinds of cheating by: Downplaying winning.

Children love to win and sometimes will do anything, including cheating, to achieve victory. Emphasize the reason for playing games or competing in sports is to have fun—win or lose. If you see or overhear them cheating, stop the game immediately and remind them of this. Teach them that any victory won by cheating is meaningless.

Prohibiting pirating.

Not only is it dishonest to download music or copy computer games without paying for them, you and your child may face criminal charges and financial penalties for doing so. Instead, steer them toward the pay-for-play sites.

Sharing stories.

When you read an article in a magazine or newspaper about an honest act—perhaps someone turning in a wallet full of money—share it with your children and talk about how important it is to resist the temptation to keep something that isn't theirs. Finally, scrutinize your own behavior. If they see you using office supplies brought home from work, overhear you talking about subtle ways to cheat on your income taxes, or witness you calling in sick when you're not, they'll believe that cheating is OK.

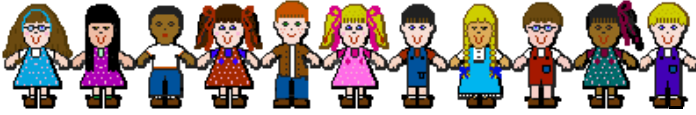

B. Presentations

1) Superintendent's Report – Supt. Peterson reviewed with the Board The Equal Employment/Affirmative Action Plan, MStM Vision, Mission and Belief Statements, the School District Financial Report Card, MStM Board Goals and the School District Needs Assessment. The Quality Support Committee met on February 1, 2010 to revisit the Vision, Mission and Belief Statements and had them cite examples of things pertaining to these statements happening in our school district. The Board will set up a workshop to update their goals after receiving the report from the Site Visit Team.

2) Principal's Report

Tom Wood announced the Character Counts Students demonstrating responsibility. The 6th Grade TAG came up with a fundraiser for Haiti and raised \$400 for Meals for the Heartland and the American Red Cross. Great Job!!

VI. New Business

A. Discuss/Approve Teacher Comments Regarding Spring Break Snow Make Up Days Supt. Peterson

Melissa Schad represented the Elementary teachers and reviewed the comments that were given to the Board.

They received an email on 01-12-10 stating, "We will be making up the days at the end of the school year." so, most of our teachers made plans after this. They realize that the snow days will affect our students learning at the end of the year. They are simply asking the school board to make an exception to the original decision to use personal leave or unpaid leave. All teachers are awarded only 2 personal days per year, unless some are carried over. Most teachers, even veteran teachers, have less than 3 available to use. Personal days and sick days are kept separate. Most of the affected staff has saved personal days for important family events, for example, graduation, grandchildren's births, etc. They have historically known that our calendar includes a Spring Break and our staff has always made plans with their families during that time. They proposed to the Board that an exception be made, and sick days be converted to personal days during this special circumstance. Christy Holloway represented the secondary staff and asked for 2 days back during the Spring Break week and thinks the kids need a break as well. Other comments included that not all the students will be here the week of Spring Break so the teachers still will not be teaching to all their needs. Bunch stated that this is a no win decision. The seniors are not happy. This is an agriculture community and those families need the help of their children in June. This is not a popular decision and at this point the decision was made because of the kids and that they are more productive in March than they would be in June. Most parents who have voiced their opinion were happy about the decision because they did not want their kids going into June and less daycare expenses for some. The Board had concerns about making any exceptions due to expenses in hiring substitute teachers and students not benefiting by having a substitute teacher for a week. The FY11 school calendar will state that snow days may need to be made up during the Spring Break week. Additional suggestions were to convert sick days into personal days. About five elementary teachers and one secondary teacher have made travel plans for the Spring Break week. Harper motioned to approve not to dock pay to teachers that have travel plans that were purchased prior to January 29, 2010 and to make up those days at

the end of the school year for curriculum purposes, seconded by Gibson. Roll call: 4 ayes.

B. Personnel Resignations Supt. Peterson

Bunch motioned to approve the resignation of Manda Gibson, Preschool Associate, the resignation of Brian Spanhut, Head Volleyball Coach, only if a suitable replacement is found, and the resignation of Grant Harris, JH Baseball Coach, only if a suitable replacement is found, seconded by Harper. Roll call: 4 ayes.

C. Personnel Recommendations Supt. Peterson

A recommendation was given to the Board to hire Nancy Kisling to fill the Preschool Associate position that is now available. The administration went back to the individuals that were laid off in December of 2009. Seniority was considered and the first individual was not interested and Nancy was. Gibson approved hiring Nancy Kisling as the new Preschool Associate, seconded by Harper. Roll call: 4 ayes.

D. Approve Soccer Sharing Agreement with Indianola Supt. Peterson

Ron Peterson, Athletic Director, has completed a signup sheet with the high school student body to gauge the interest in playing soccer this spring 2010. Only two students signed up; one Junior and one Senior. The cost to the district for soccer last year for four students was \$1,200 plus \$2,120 for transportation costs. The recommendation from Peterson was not to offer soccer this spring due to lack of interest and the financial burden to the district. The Board asked if the two students who signed up have played soccer in the past and the administration stated yes, they are passionate soccer players and receive sufficient playing time. Gibson motioned to approve paying the \$300 per student that expressed interest as long as transportation is provided by the student, not by the school, seconded by Bunch. Roll call: 4 ayes.

E. Approve to clear Preschool Fund Balance Jill Gavin

Gavin stated that the appropriate coding had been created to move the Preschool Fund 63 into the General Fund. The negative amount is due to the previous years of five year old students' tuition that went into the General Fund and not into the Preschool Fund. Per the auditors, the Board would need to approve paying off the negative amount in the Preschool Fund at the end of January; which is \$23,989.81. The Board

would still like to see the revenue and expenses for the Preschool program and Gavin will still show that on her report. Bunch motioned to approve paying off the negative amount of \$23,989.81 to eliminate the Fund 63 and move those revenue and expenses into the General Fund, seconded by Harper. Roll call: 4 ayes.

F. Discuss/Approve Closing the Daycare Program
Supt. Peterson

Due to the budget cuts that were announced in October, the Board had requested to review all programs. The daycare program, at the time of the cuts in October, was in the negative. Gavin provided numbers to the Board that showed revenue decreasing and expenses increasing over the past three fiscal years. It was stated that in the 2008-09 school year, the daycare program lost 12 children but we kept the number of staff members. Staff cuts were made in August 2009, craft projects were cut, and hours were adjusted for the current staff. Expenses included salaries and benefits, groceries, crafts, and summer transportation.

The Board thanked the parents again for their comments in regards to keeping the daycare program open. The Board has asked the administration and the head of the daycare program to create a survey generated by the ideas given by the families and allow the entire community to answer the survey. The Board recognizes that the families want to make this work and that increasing the prices of daycare would be acceptable. The Board suggested finding ways to promote and advertise the daycare program by creating awareness. The Board also asked for a profit model to anticipate costs and benefits and recommended running the program as a business.

G. Review 2008-2009 Audit Jill Gavin

The superintendent and business manager reviewed the 2008-2009 audit with the Board, noting where we are with their recommendations.



The President called the meeting to order at 5:12 p.m.


