Ms. Reeves moved to be remembered that on this 26<sup>th</sup> day of April 2021, the Board of Directors of Martensdale-St. Marys Community School District met in regular session for the purpose of a hearing upon the budget estimate as filed with the Board. There was found that the notice of the time and place of the hearing was in accordance to the *Code of Iowa* and as directed by the Board was published on the 14<sup>th</sup> day of April, 2021, in the *Record Herald & Indianola Tribune*. Thereafter and after hearing all taxpayers desiring to be heard, the Board took up the estimate for final consideration and determined that the said estimate be corrected and completed so that when completed it should be in words and figures as stated herein. The vote upon final adoption of the budget with a tax levy of \$15.64596 was seconded by Mr. Bowlin. Roll call: 4 Ayes.

The Secretary was thereupon directed to forward the adopted budget and tax levy to the county auditor as provided by law.

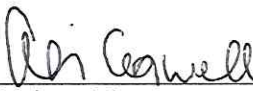
